The PowerLung Limited Warranty covers all defects in materials or workmanship encountered in normal use of the PowerLung unit and does not apply to the following:

- a. Loss of or damage to the PowerLung unit due to misuse, abuse, alteration, accident, maintenance, repair or services not by PowerLung, Inc.
- b. Failure to follow operating, maintenance and cleaning instructions as outlined in the PowerLung instructions.
- c. Fading and discoloration due to age and use.
- d. Use of parts or supplies that cause damage to the PowerLung unit.
